### ***What is Title I?***

Hembree Springs Elementary School is identified as a Title I school as part of the Every Student Succeeds Act of 2015 (ESSA). Title I is designated to support State and local school reform efforts tied to challenging State academic standards in order to re-inforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parent and family engagement. **All Title I schools must jointly develop with all parents a written Parent And Family Engagement Plan.**

## ***Parent and Family Engagement Plan***

**What is it?** This Parent and Family Engagement Plan describes how Hembree Springs Elementary School will provide opportunities to improve parent and family engagement to support student learning. Hembree Springs Elementary School is committed to the goal of increasing the number of parents involved in influencing the success of all students through academic support and school activities and programs. This plan describes the different ways that Hembree Springs will support parent and family engagement and how families can help plan and participate in activities and events to promote student learning at school and at home.

**How is it developed and revised?** Hembree Springs Elementary School welcomes input and comments from all parents and family members in the school at any time regarding all parts of this plan. This plan is posted on our school website for parents to view and send feedback throughout the year. Feedback can be sent at any time using the feedback form available online or requesting a paper form with the Title I Parent Liaison. The school also distributes an annual parent survey online and a hard copy and hosts two Parent Input Meeting in the Spring to ask parents to review and revise this plan. These same input/feedback opportunities are offered to parents regarding the Title I Schoolwide Plan, the School-Family Compact, and the reserved Title I funds for parent and family engagement activities. Any comments or feedback showing the Title I Schoolwide Plan is not satisfactory to parents will be submitted to the District Title I Office. All feedback is considered before the Title I documents for the new year are finalized and approved. Each year the PFEP is updated to meet the changing needs of parents and the school. All parents are welcomed to be part of the decision—making process by completing the feedback form, annual survey and by attending the Parent Input Meetings.

**Who is it for?** All students of Hembree Springs Elementary School and their families, are encouraged and invited to fully participate in the opportunities described in this plan. Hembree Springs will provide full opportunity for the participation of parents with limited English, parents with disabilities and parents of migratory children.

**Where is it available?** The plan is first discussed at our Annual Title I Parent Meeting at the beginning of the school year. This plan is sent home with all our students in Friday's folders during the month of October. The plan is also available on the school website in the *About* section under *Title I*. The District requests the PFEP also be available in the community at our local library.

- 2) Decrease by 20% the number of students (1-5) in Intervention or Urgent Intervention in **Math** benchmarks by May 2020.\*

# ***School Measures to provide Required Assistance***

Hembree Springs will take the following measures to promote and support parents and family members as an important foundation of the school in order to strengthen the school and reach our school goals. We will -

- Ensure that all information related to school and parent programs, meetings, and other activities is published in both English and Spanish, posted on the school website and included in the school newsletter for all parents.
- Share information in English and Spanish during parent meetings and conferences for parents to understand the school's academic standards and assessments as well as the ways parents can monitor their child's progress and work with educators.
- Each semester the staff receives training on the value and utility of contributions of our parents, how to reach out, communicate and work with parents as equal partners. And how to better build ties between home and school. Continuous methods are provided for the staff throughout the school year.
- Communicate with all families on a regular basis regarding the Title I programs and activities using various methods as phone messages, emails, flyers, school newsletter and school website.
- Provide Parents conferences with grade level teachers at SOAR Night and discuss the School Compact and student progress.
- Provide necessary materials and handouts for parents at conferences, meetings, and in the *Parent Resource Center* to help parents support student learning at home.
- Share information and hold meetings for local Pre-K programs and parents with kids transitioning to kindergarten and middle school to help prepare them and their child for a successful transition.
- Host and/or collaborate with the community to offer classes such as technology and English as a second language to help further enhance parents' various educational levels as well as the Harms of Copyright Piracy.
- Offer childcare for students during parent meetings and workshops in the evening hours.
- Conduct parent meetings in the morning and evening to facilitate attendance by most parents and post electronic presentations and handouts, when available, in the school website.
- Use the Parent Resource Center as a place to keep presentations and materials for parents unable to attend parent meetings and to offer individual or small group redelivery of presentations during the day if requested by parents.
- Collect feedback from parents at all events in order to respond to parents' requests for additional support for parental involvement activities, and allow parents the opportunity to give input on the use of the 1% parent engagement funds.
- Provide information on transportation options so it is not a barrier to parent and family engagement.
