- Your school is responsible for monitoring the implementation and effectiveness of the strategic initiative(s) associated with your waiver(s), as well as for submitting annual reports about the initiative(s) to the district. Based on the results of your ongoing assessment, your school must also determine whether the school wishes to continue to use the flexibility granted.
- The district's Research & Program Evaluation department will support your school with its ongoing monitoring and evaluation responsibilities to help you share your key learnings with school and district stakeholders. Your school will be provided a toolkit outlining the district's program evaluation strategy and, specifically, how the strategy will be applied to evaluate the effectiveness and impact of RFF waivers. A representative from the Program Evaluation team will schedule a meeting with your school leader in the coming months to begin discussing how these standard indicators will be tailored to help you assess the impact of your specific RFF waiver(s) and tools that will be available to you to ensure timely reporting and documentation of findings.
- Your school may use the waiver(s) that are outlined above for the duration of the strategic plan with which the waiver(s) is/are approved. The school may discontinue the use of the waiver(s) by a majority vote of the Council members then in office. Please note that the Superintendent may, at any time, revoke approval of RFF proposals that are deemed ineffective or unsuccessful.

In addition, please know that our district staff is available to provide guidance and support to your school leadership team during the implementation phase of your RFF proposal(s).
